# Perak



Perak, also known by its honorific Darul Ridzuan “Land of Grace” and in English, the word “Perak” literally translates as “Silver”; hence Perak is also popularly referred to as the “Silver State”. Perak is the second largest state in Peninsular Malaysia and fourth largest state in Malaysia. Its capital is the town of Ipoh. Perak is a land prized by natural tropical beauty and rich in a history of culture. Agriculture is also one of Perak's main industries, especially those concerning rubber, coconut and palm oil. Tourism is a growing industry given the state's abundant natural attractions

- **Transportation**

Perak is Malaysia first inland port, the Ipoh Cargo Terminal (ICT), is strategically located at the heart of Ipoh City. It allows seamless goods movement within and around the Kinta Valley to Port Klang Ipoh has a modern railway called Electric Train Service (ETS) runs throughout the Perak state. It takes about 1.5 hours from Ipoh to Penang and 2.5 hours from Ipoh to Kuala Lumpur, giving convenient connectivity to the two major market and industrial hubs in Malaysia. Whereby, its Sultan Azlan Shah Airport has been accommodating commercial jet aircrafts and multiple daily flights to both domestic destinations and Singapore.



- **Strategic Location**



Perak is strategically located at the mid-point of Kuala Lumpur / Selangor and Penang, which collectively constitute about half of Malaysia's GDP and represent one-third of the country's population. Perak is easily accessible via the 775-kilometer North-South Expressway that effectively connects all major cities in Malaysia, Perak is also served by the Electronic Train Service that runs between the state capital Ipoh and Kuala Lumpur; the inland port known as Ipoh Cargo Terminal; two established sea terminals at the Lumut Maritime Terminal and the Lekir Bulk Terminal; and the Sultan Azlan Shah Airport located just six kilometres away from Ipoh's city centre.
